Membership Contract

Freeport is dedicated to advancing a free, just, and equitable society. As such, we are committed to creating a safe and vibrant community that is respectful, and welcoming to people from all different backgrounds and across the world. However, only when we treat people with mutual respect and dignity can we truly come together to share a free society. We believe in living a more natural way of life. To be self sufficient, grow our own food, produce our own goods. We choose to not be constant consumers of the world. We hope to help make the world a better place for future generations.

Peace:

We are a peaceful, self governing society. We want to see world peace. We believe all people have the right of self determination, and are free to live as they see fit. We are all human beings, and shall be treated with peace, love and respect for one another. Regardless of our differences, we can all live peacefully. We know and respect that different cultures do not mix together, and that people should live in a society which shares their culture. Not to try and take over another culture, or change another society.

Membership:

Membership is consensual and subject to this membership contract. Members must be at least 18 years of age, or 14 years of age, if their parents are members. Children under 14 years of age, and who's parents are members, shall have the same benefits as other members, under the control of their parents. All members must have a signed membership contract. Membership may be terminated by either party, for any violation(s) of this membership contract. Membership termination must be in writing, with at least 30 days notice. Membership is required to live in the community.

Membership Fees:

10 year membership = \$20,000 USD Lifetime membership = 1 BTC

Self Sufficiency:

It is our responsibility to build a self sufficient community. Both on the Administration and Member sides. As things get built, the ability to take care of ourselves is stronger. We strive to live within our means, and in tune with nature. To help protect the natural environment, not harm it. To grow organic foods, look after each other, and leave things in a batter state then they where found. To not do or use things which harm the environment. To produce for our own needs, such as food, power, housing, community, technology and any other needs. To treat one another with love and kindness.

Sustainability:

Sustainability is a key part of the community. We pledge to live a more self sufficient and sustainable life. For ourselves, future generations and the environment. In order to do this, all growing of food must be organic. Use of fossil fuels needs to only be used, when no other option is available, and needs to be eliminated over time.

Parental Rights:

Children belong to their biological parents. As such, parents have full authority over their own children, and are responsible for them, their well being, health, education and all other needs of the

child. Parents have the right to know, what is going on with their children. If a child is born to parents who are members of Freeport, the child is considered an adult, and responsible for their own actions, and well being starting at the age of 14 years old. The Community Court, may step in, if the child's Human Right's are being violated.

Age of Responsibility:

14 years of age. By this age, people know the difference between right and wrong. They are held accountable for their own actions. It is their parents responsibility to teach and prepare them for these things. Age of consent is 14. Pedophilia and other sexual abuse, is not tolerated, and is subject to the death penalty.

Vessels:

All vessels shall be seaworthy. Vessel's are the responsibility of their registered owner, as such the owner of the vessel is responsible for the safety of everyone on board. If a vessel is abandoned for more then 3 months, it can be seized by the Administration. In the event of a members death, the vessel will go to surviving family. If there are no surviving family, the vessel will become property of the community. Vessels which are not seaworthy may be sunk, or otherwise reused.

Self Defense:

Everyone has a right of self defense. In the event their life is in danger, they may use lethal force to defend themselves. But they do not have the right to attack others. Provoking someone else to attack, is not self defense. Individuals 14 years of age or older, may use non lethal weapons, such as stun guns, tasers, pepper spray, pepper spray or salt guns, paintball guns, CO2 guns, ect. Individuals aged 18 and over, may own and use firearms, as defined under Gun Ownership.

Gun Ownership:

Members over the age of 18 may own firearms. Members are fully responsible for any and all actions taken with their firearm. It is the members responsibility to be trained to use their firearm, and firearm safety.

Public Safety:

Public Safety is the communities responsibility. As we are a developing society, guards may not always be available. If and/or when a guard is not available, it is the members responsibility for their own safety. In the event of any attack, it is all members responsibility to help protect and defend the community as a whole.

Identification:

Identification cards are issued to all members. Identification must be provided upon demand of a guard, or any member of the Administration. Failure to provide identification upon demand, is a crime, and will be brought to the Community Court. Identification cards are issued at time of membership, and are valid for 5 years. If your membership is terminated, any and all identification issued by the Administration must be turned in.

Community Court:

The Community Court is responsible for all civil and criminal matters with Freeport, and its members. The court is headed by the Prime Minister, who may appoint members of the Administration, to serve as Judge's and other officers of the court. All civil and criminal matters involving any member of Freeport, must go thru the Community Court. Even if the offense happened in another Nation State, or otherwise outside of Freeport's jurisdiction. The community court has full jurisdiction of all members, and members must fallow any and all rulings made by the

court. Visitors to Freeport, are subject to the laws of Freeport, and are subject to the Community Court if they violate any of our laws.

Governing Body:

Freeport is a theocratic monarchy, with the Prime Minister as the head of state. The Administration is tasked with all governing matters, and serving all members of Freeport. All members of the Administration are required to know and fallow International Law. By becoming a member of Freeport, you freely and willingly consent to the terms of this membership contract, and are bound by it's terms, and the laws of Freeport.

Community Spaces:

Community spaces are all public areas, and are open to all members. Community spaces are owned by the community as a whole. The Administration may temporarily close community spaces and area's, if its a matter of public safety.

Organic Foods:

All food grown in the community, must be organic. No GMO's are allowed. Use of toxic chemicals on any plants, grain or food is strictly prohibited.

Outside Trade:

As Freeport is a developing society, we may not have everything people may need. As such, members are allowed to get what they need, that the community does not have, from outside trade. There is no import fee, for anything brought into the community.

Membership Contract Renewal:

This Membership Contract is renewed every 10 years. Upon which a new membership contract must be signed. This allows for changes to be made from time to time, and ensure the current contract is fallowed. New contracts must be made available for review, 30 days before they are renewed.

Death Penalty:

The Death Penalty is only to be used for violent crimes, crimes against children, pedophilia and other heinous crimes. If violence or other acts where done in self defense, they are justified and exempt from the death penalty. The death penalty must be ordered by the community court, after a trial. If a death penalty is issued, it must be carried out within 30 days, from the date it was issued.
